Privacy Policy

The Guardian Angels for Soldier's Pet© (the Organization) "Privacy Policy" describes how we treat your personal information we collect when you visit our site.

I. Privacy Statement

Guardian Angels for Soldier's Pet © agrees to respect and observe the provisions set forth in the Personal Information Protection and Electronic Documents Act (the "ACT") and any other relevant privacy legislation. In addition to that extent if there is additional protection afforded to you pursuant to the "ACT" or any other legislation, and not set forth herein, the Organization agrees to take such measures to give full effect to such additional protection.

II. Online Collected Information

Guardian Angels for Soldier's Pet© does not collect personal information(full name, mailing address, phone # and email address) from those visiting our site other than the personal information requested from a visitor who chooses to be added to our "Mailing List" (has the option to opt out any time).

Personal information (name, mailing address, phone numbers, and email addresses) is collected by the Organization as provided by the visitor when accessing any applications available on-line that can be printed, filled in, and submitted to the Organization's National office electronically (via this website or via fax).

III. Confidentiality

Personal information provided to our Organization is not shared outside of Guardian Angels for Soldier's Pet©, except as required by law, is considered as "Confidential Information" and only shared within the Organization with those with a "need to know".

We follow and adhere to the military security guideline, commonly known as "OPSEC/PERSEC" as available HERE in regards to confidentiality and sharing of any personal information provided to the Organization. In addition, for security purposes and to ensure we are following the "OPSEC/PERSEC" guidelines, we do not provide our Clients', name of a specific foster home (commonly known as Guardian Angel), the pet or pets' names, or the exact location where a specific pet is being fostered.

IV. How Your Collected Personal Information is Used

Unless you otherwise consent, we will use your personal information only for the purpose for which it was submitted, such as to reply to your emails, to register you as a volunteer with the Organization, to process donations (received via PayPal or another 3rd Party donation service provider), to submit requested information of your interest to possibly open your heart and home to foster a specific active duty military or veterans' beloved pet or pets, or to submit a specific pet or pets requested information.

V. How Your Personal Information May Be Used

Guardian Angels for Soldier's Pet© does not share your personal information to anyone outside of the Organization, except as defined below, nor do we sell or rent your personal information. The only time your personal information might be shared outside of the Organization would be under the following circumstances:

- Where release is required by law (for example, a subpoena) or regulation or is requested by an U.S. government agency
- Where our records or a message is left on any of our official Social Media sites that indicates that someone may be engaged in fraudulent activity or other deceptive practices that a U. S. government agency should be made aware of
- To appropriate persons or agencies, where your communication suggests harm to others

VI. Computer Tracking and Cookies

Guardian Angels for Soldier's Pet© website is not set up to electronically track, collect, or distribute personal information of visitors to our site. Our site logs may generate certain kinds of non-identifying usage data, such as the number of hits and visits to our site. This information is used for internal purposes, but we cannot identify the visitor or the visitor's IP address.

A cookie is a small amount of data that is sent to your browser from a Web server and stored on your computer's hard drive. The Organization uses non-identifying cookies to provide easier site navigation and access to forms available via our website. You can still visit and use our site if your browser is set to reject cookies. Our cookies do not generate personal data, does not read personal data from your computer, and are never tied to anything that could be used to identify you.

VII. Security

We use physical, electronic, and administrative safeguards to assist us in preventing unauthorized access, maintaining data accuracy, and correctly using your submitted personal information. Except as specified in the Privacy Policy, we use commercially reasonable efforts to limit access to your personal information to volunteers of Guardian Angels for Soldier's Pet© on a "need-to-know" basis.
